The Office of Standards, Curriculum & Assessment Development (OSCAD) has extended the testing window for Dine Language Proficiency Assessment (DLPA) to October 30, 2025 due to the fact that some schools need more time to complete the assessment. The OSCAD department scheduled DLPA training on October 6, 2025, and October 8, 2025, beginning at 9:00 AM virtually.

The Policy and Procedures for PRE and Post DLPA will be adhered to by schools.

- Test Administrators are required to attend the Pre-DLPA training.
- Test Administrators must submit a Registration Form. The Team link will be sent to Test Administrator based on the Registration Form.
- Test Administrators must complete the Test Security Form
- **Trained Test Administrators are the only ones who can pick up and return test materials OR someone who has preapproval with clear communication between OSCAD and school.**
- Test Administrators who have attended the training must sign test security form before distribution of test materials in person. OSCAD staff will check the test materials and sign off on the form when the test materials are returned. Test materials cannot be mailed.
- Extension has been made for the 2025/26 PRE DLPA test window; the test window is open to October 30, 2025.
- If there is an issue with test material: ie missing form on booklet, rubric, etc. The test administrator must contact OSCAD. The test materials cannot be duplicated.
- The last day to return test materials is October 30, 2025.
